During this year, Rolling Start NC presented 22 vehicles to local residents. The value of these vehicles, which includes the original donor's contribution, is \$65,933. All of the labor was provided at no cost by our team of volunteers. Many local suppliers of parts and machine shop services provided Rolling Start NC with parts and services at no cost or reduced costs. In addition to the vehicles granted another 38 vehicles are in-process of being refurbished. Over \$10,696 has been expended in the process of refurbishing these vehicles. The total costs shown in 28a includes all related Shop Costs and materials needed to refurbish all of the vehicles listed above. It does not include any administrative costs or the cost of the Mechanic listed in 29 below.

Part and Line Number: **Part III - Line 29**

Rolling Start NC has been very fortunate to have received a Capacity Building grant to help boost the number of vehicles turned out each year. This grant addresses a part-time administrative support person and a part-time mechanic who started in July of this year. We have recognized an increase of 8 vehicles granted this year (22) versus (14) from last year. This is a 57% over the entire year while the mechanic was only on board for 6 months. We look forward to having that help next year for the entire year as the grant will cover the entire 2024 year. The costs shown in 29a are for the salaries and payroll taxes related to the Administrative Assistant and the Mechanic.
